# PROCEDURE FOR NOMINATION AND ELECTION OF THE BOARD OF DIRECTORS

### The principal guiding elements of the procedure are outlined as follows:

- ➤ The number of members of the WFMH Board of Directors will be a minimum of 18 and a maximum of 24 members elected by the Voting Member Organizations for a term of two years.
- The slate will consist of candidates that have been qualified by the Nominating Committee (e.g., eligible to be elected, recommended by a current Voting Member Organization, current Affiliate Member Organization, current Individual or Life member, or current Board member, and who have confirmed willingness to serve based on published guidelines and expectations, and have been duly vetted by members of the Nominating Committee etc.)
- ➤ Members of all categories, whose dues are in current standing prior to closure of nominations at midnight GMT 19<sup>th</sup> June 2025, are eligible to submit candidates for consideration by the Nominating Committee.
- ➤ Voting Member Organizations, Life Members and current members of the Board of Directors will be eligible to participate as Voting Members in balloting for election of the Board. Voting Members eligible to participate in the election are those whose membership dues are current at the time of the election.
- > The Nominating Committee will present a slate of nominees to the Voting Members consisting of up to 36 qualified candidates from which the available number of Directors will be elected.
- Utilization of an official ballot that will allow for election through balloting of eligible Voting Members.
- Board Members are eligible for election to serve up to four consecutive twoyear terms, after which they are ineligible for re-election for a period of two years.
- > Each of the seven (7) WFMH regions will preferably have at least one (1) person on the Board.
- ➤ The election of Board Members will be conducted by electronic ballot only completed within approximately 120 days of the next Voting Member Assembly meeting.
- > In the case of persons holding (or elected to) positions of President-Elect, President, and Immediate Past President, exemption to the term limits would apply until completion of those terms.

- Following the tabulation and certification of the ballots for the candidates of the Board, the Nominating Committee will meet for the purpose of choosing positions for the Officers [President-elect, Secretary, Treasurer, Vice-President Constituency Development, Vice-President Program Development and Vice President for Administration], Regional Vice-Presidents, Directors and the Board Lead for Lived Experience.
- > The Nominating Committee's final slate of Officers, Directors and Regional Vice-Presidents will be a "single slate" with one candidate nominated for each office.
- The final slate of candidates will be submitted to the Board of Directors with a deadline for return to the election referee Nomination Committee Chair for validation 60 days prior to the convening of the Voting Member Assembly.
- > The slate of newly elected Board Members will be announced to the full Membership prior to the meeting of the Voting Member Assembly and will be officially installed at that Meeting.

#### Identification and Qualification of Candidates

The following guidance is provided to the Nominating Committee for the process of identifying and recommending candidates for consideration as nomination to the Board of Directors:

- ➤ Voting Member Organizations of national scope, Affiliate Member Organizations, and Individual/Life Members are eligible to recommend candidates from their country to the Nominating Committee for consideration.
- Voting Member Organizations of global or international scope or membership are eligible to recommend candidates for consideration from any country.
- > Current members of the Board of Directors are eligible to recommend candidates for consideration from any country.
- ➤ The Nominating Committee is authorized to seek, identify and consider additional candidates in order to balance the geographic, skills, influence, professional and regional needs of the slate of candidates.
- > The Nominating Committee's proposed slate of nominations does not require approval or adjustment by the current Board of Directors prior to submission to the Voting Members.

### **Composition of the Nominating Committee**

The WFMH Nominating Committee will be comprised as follows:

- ➤ The Immediate Past President will serve as the Chair of the Nominating Committee.
- ➤ The Secretary General shall be a non-voting member of the Nominating Committee.
- ➤ The members of the Nominating Committee will be elected by the Board of Directors at the first meeting following the biennial election from a single slate of nominees prepared by the outgoing Nominating Committee.
- ➤ The committee will normally be composed of eight [8] members, including the Chair and one (1) member from each of the other 6 WFMH regions (the Chair will represent the region in which he/she resides) and the Secretary General (non-voting member).
- ➤ Everything must be done to find an appropriate member for each region but if there are no further candidates for consideration the Chair working in collaboration with the Secretary General and Nominating Committee Members will either choose a person of the nationalities within that region or reduce the committee accordingly and alert the committee members of the need to pay special attention to the region/s without representation.
- Members of the Nominating Committee may be either past Board members who are not candidates for consideration for nomination or current members of the Board who are not eligible, or who have chosen not to be considered for re-election. The Immediate Past President is exempted from this requirement.
- Members of the Nominating Committee will serve for a term of two years and may be re-elected to one additional two-year term.
- ➤ The current sitting President and President-elect will serve as advisors to, but not as voting members, of the Nominating Committee. The final election results will be made available to the EC and Board if requested.

On behalf of the Chair of the WFMH 2025-2027 Nominating Committee, Nasser Loza and Nominating Committee Members it gives me great pleasure as Secretary General to call for candidates to be considered for nomination and election as Directors to the 2025 – 2027 WFMH Board of Directors.

The Nominating Committee Process and Handbook 2025-2027 is available on the WFMH website.

We sincerely encourage your participation in the process of assisting the Committee to identify qualified and committed candidates for consideration.

This year's procedure to nominate and elect members to the WFMH Board of Directors continues the process of a more interactive and more inclusive approach to nominating and electing the WFMH Board of Directors that was begun with the 2007-2009 elections process.

By action taken at the October 14, 2006 WFMH Voting Member Assembly meeting in Oslo, Norway, the WFMH Board is elected through a ballot procedure in advance of the Voting Member Assembly.

The Nominating Committee places before the eligible Voting Members a ballot containing up to 36 qualified candidates from which all the Directors are elected with a standard that each nominee should complete a detailed Application Form.

Nominating persons/referees will be contacted to complete a standardised Refence Proforma and standardised screening interviews will take place with each nominee conducted by members of the Nominating Committee once nominations are closed.

The details and process for submitting qualified candidates for the Nominating Committee's consideration are contained in the accompanying "Call for Candidates" packet. I encourage you to review these materials carefully, and to nominate candidates for the 2025-2027 WFMH Board of Directors.

There has been a request regarding the need for a more structured variety of stakeholders on the Board of Directors. As a result, there will be a focus on, but not limited to, representation from the following groups:

- > People with lived mental health experience /consumers.
- Family members/carers.
- Psychiatrists, psychologists, social workers, nurses, family doctors and other professionals and providers with an interest in mental health advocacy.
- Administrators, researchers, lawyers, accountants and policy-makers with an interest in mental health advocacy.
- Appropriate skills and experience in management of International NGO's

The Nominating committee will ensure adequate regional and group representation. At least one (1) member of the Board of Directors must come from each of the WFMH Regions as described in Article IV, Section 1.

Please be aware that the **deadline** for completed Candidate Information Forms and all supporting materials to be received at the WFMH Secretariat **is Midnight GMT Thursday 19 June 2025** 

The Nominating Committee will be unable to consider candidates for whom information arrives after that time and date.

Thank you for your consideration and participation in this important process through which the leaders of the World Federation for Mental Health will be selected.

Included in this document you will find several items needing your attention.

Review all documents carefully, make sure everything is signed and that you include all supplemental material.

# WORLD FEDERATION FOR MENTAL HEALTH CALL FOR CANDIDATES FOR NOMINATION 2025 – 2027 BOARD OF DIRECTORS

The Nominating Committee of the World Federation for Mental Health invites eligible individual members, life members, affiliate member organizations and voting member organizations to submit the names and relevant background information of potential candidates for nomination for election to the WFMH Board of Directors for the 2025-2027 term.

All required information for candidates must be received by the WFMH Secretary General Office no later than **Midnight GMT Thursday 19 June 2025**.

Submissions received after that date and time will not be considered.

#### **Who May Submit Candidates for Consideration:**

Candidates for consideration by the Nominating Committee for election to the WFMH Board of Directors may be submitted by:

- An official representative of a WFMH Voting Member Organization whose membership in WFMH is current at the time of submission may submit candidates residing in any country in which it operates.
- ➤ An official representative of a WFMH Affiliate Member Organization whose membership in WFMH is current at the time of submission may submit candidates residing in the country in which it operates.
- An Individual, Life Member of WFMH whose membership in good standing at the time of submission or current members of the WFMH Board of Directors may submit candidates residing in any country.

#### **Eligibility for Consideration:**

To be considered eligible for nomination to the election ballot, individuals must:

- Be a dues-paying Individual or Life Member of WFMH, with their annual dues current as of the date of submission of their candidacy to the Nominating Committee.
- Be in full agreement with, and willing to promote, the vision, mission, goals, and strategic objectives of WFMH.
- Have their candidacy submitted by an Individual, Life, Affiliate Member Organization, Voting Member Organization whose membership in WFMH is current at the time of submission, or by a current member of the WFMH Board of Directors.
- Be agreeable to having their name submitted for consideration of inclusion on the ballot of qualified candidates for election as a Board Member.

- Have signed the attached agreement of understanding and expectations of WFMH Board membership.
- Have no known conflicts of interest (personally or professionally) that would prevent active service on the WFMH Board and representation of WFMH on matters of policy and procedure.
- You will need to confirm if you are subject to any of the following:
  - A professional who is under investigation for professional misconduct, or has been found to be in breach of appropriate professional standards by the relevant professional body.
  - A subject of a bankruptcy restrictions order or interim order.
  - Dismissed (except by redundancy) by any Board or NGO role.
  - Have had an earlier term of appointment terminated.
  - Have been removed from trusteeship of a charity/NGO.
- > Submit a personal statement of a maximum 1,000 words outlining:
  - Your relevant experience in mental health advocacy, education and awareness and your personal experience and perspective that you would bring to the WFMH.
  - List other organization and boards you have represented and any with the WFMH.
  - Current type and length of WFMH membership.
  - Why you are interested in serving on the Board of the WFMH?
  - Areas where you intend to contribute to the functioning and betterment of the WFMH (if you are or have been a WFMH Board Member, you must indicate any fulfilled contributions in these areas).
  - The specific skills that you wish to bring to WFMH.
  - How would you identify yourself such as: Consumer, Family Member, Psychiatrists, MH professional, Administrator/Director of a mental health NGO, etc. Please list all that you believe you would use in your role as a WFMH Board Member.
  - As our organization is spread around the world, we have few opportunities to meet in person and much of our communication is done via email and web-based conference calls. Are you willing and able to participate in Board Meetings held at specific meeting sites, on conference calls and/or with email communication? Are there any issues that would prevent you from being available for any of these meetings?
  - ➤ Submit an optional statement of a maximum of 150 words if you wish to be considered for any of the WFMH Executive Roles or Board Lead for Lived Experience to highlight the skills and expertise that you would like the Nominating Committee to take into account during their considerations.

- Obtain the necessary signed agreement from the potential candidate to be nominated and, if elected, serve as a member of the WFMH Board of Directors.
- > Complete the attached WFMH Candidate Information Form.
- Submit WFMH Candidate Information Form, along with the Candidate's Personal Statement and signed Agreement of Understanding of the Expectations of WFMH Board Membership, to the WFMH Secretariat to be received no later than midnight GMT Thursday 19 June 2025.

- Submit a personal statement of not more than 1000 words.
- Submit an optional statement of a maximum of 150 words if they wish to be considered for any of the WFMH Executive Roles or Board Lead for Lived Experience.

#### **EXPECTATIONS OF MEMBERS OF THE WFMH BOARD OF DIRECTORS**

- Board members shall support and develop the WFMH global mission and goals of improving the mental health of people everywhere.
- Board members shall abide by the by-laws and policy and procedures of the organization.
- Board members are required to attend regular and special Board meetings and the WFMH World Mental Health Congress (WFMH typically does not provide reimbursement of expenses for attendance at Board meetings or Congresses). Board members must be prepared to provide their own support for attending Board meetings.

- Board members are expected to attend an orientation session.
- Board members are required to participate actively on at least one committee if requested by the President.
- Board members are expected to contribute to the financial stability of the organization, including being a paid Individual or Life Member.
- Board members are expected to share their expertise with the organization
- Board members are expected to read all materials that are distributed and respond in a timely fashion
- Board members are expected to hold in confidence any restricted information given to them in their capacity as a member of the Board
- Board members are expected to take initiatives and to provide leadership as needed. and will be expected to participate actively in the World Federation's programs
- Board members are expected to declare any possible conflicts of interest and ask that the minutes so state
- Board members are expected to promote and encourage mental health organizations in their country, or in which they are active, to become members of WFMH
